Series 1: Purchase and Design

Biographical / Historical

This series documents key figures who shaped Planting Fields during the early part of the twentieth century, when the Coe family purchased the property from the New York-based couple Helen and James Byrne in 1913. Helen Byrne (1869-1945) was an art collector and patron, and James Byrne (1857-1942) was a prominent attorney. The Byrnes had worked with the architect Grosvenor Atterbury (1869-1956) and landscape architect James Greenleaf (1857-1933) to create a picturesque country estate and gardens on the North Shore of Long Island. The documentation housed in this series traces the history of landscape design, gardening, and architectural work at Planting Fields, specifically the endeavors that commenced upon the Coe family's stewardship of the property, which extended the efforts begun by the Byrnes. The Coes engaged Lowell and Sargent and later the Olmsted Brothers firm (1898-1961) to enhance the landscape and gardens of Planting Fields. At the same time, the architectural partnership of Walker and Gillette, Architects (1906-1945) was commissioned by the Coes to enhance the built environment of the property, first by creating farm buildings and later, after a catastrophic fire destroyed the Byrne house in 1918, to design a new residence for the Coe family.

Scope and Contents

This series represents the development of Planting Fields in the early twentieth century, documenting the contributions of many individuals, including architects, landscape architects, artists, craftspeople, and patrons, whose efforts culminated in a transformative work of lasting impact, synthesizing elements of art, architecture, landscape design, and horticulture into a cohesive whole. The series contains deed agreements, property purchase papers, and assorted correspondence concerning the Coe family's

commissions of artwork, architectural designs, landscape designs, and related materials pertaining to specifications, labor, materials, cost estimates, and payments.

Box 1: Planting Fields history and deeds

Scope and Contents

This container houses documents pertaining to the property ownership history of Planting Fields, including the augmentation of acreage with purchases of adjacent farmland. Files comprise original and photocopied materials.

Box 2: Helen Byrne, Lowell and Sargent, Everett Shinn, 1914-1918

Arrangement

This box is arranged by subject and date.

Scope and Contents

This container houses documentation pertaining to the early years of the Coe family's acquisition of Planting Fields and enhancements thereto. Materials include listings of furniture and decorations belonging to Helen Byrne, the former owner of Planting Fields, and related correspondence with the Coe family regarding possible purchases of items from Byrne's collection. Additional documentation concerns Everett Shinn's painted decorations for the interiors of Mai Coe's teahouse at Planting Fields, with handwritten letters from Shinn pertaining to this project. Finally, the involvement of Lowell and Sargent is represented in correspondence primarily with Lowell, which concerns the landscape architecture and garden planning at Planting Fields, such as greenhouse specifications, labor availability, and the processes for transporting a pair of massive beech trees from the Rogers family home in Fairhaven, Massachusetts.

Biographical / Historical

Helen Byrne (1869-1945), a New York-based art collector and patron and the wife of attorney James Byrne (1857-1942), began assembling parcels of land at Planting Fields in 1904 to create a country estate and garden for her family. The Coe family acquired Planting Fields from the Byrnes in 1913

and engaged the landscape architects Lowell and Sargent to begin a project of further landscaping and developing gardens on the property. Guy Lowell (1870-1927), a member of a prominent Boston family, was an architect and landscape architect who worked on numerous public and private commissions for notable clients. Lowell was also the author of several books on gardens. Lowell's partner, Andrew Robeson Sargent (1876-1918) was born in Brookline, Massachusetts, and graduated from Harvard in 1900. His father was Charles Sprague Sargent, noted botanist, professor, and director of the Arnold Arboretum at Harvard. Everett Shinn (1876-1953), painter, illustrator, muralist, and set designer, worked frequently with the architects Walker and Gillette and may have been introduced to Mai Coe by the firm. Shinn designed and decorated the Tea House at the south end of the Lowell and Sargent-designed Blue Pool Garden at Planting Fields.

Box 3: Walker and Gillette, Architects, 1915-1919

Arrangement

This box is arranged chronologically by date.

Scope and Contents

The Coes engaged the architectural firm of Walker and Gillette to design farm buildings for the estate at Planting Fields. This work took place during 1915-1919. Materials in this container document negotiations of cost estimates and payments for the design and construction of the farm buildings, along with correspondence with Cauldwell Wingate Company-builders.

Biographical / Historical

The New York-based architectural firm of Walker and Gillette was founded in 1906 by A. Stewart Walker (1876-1952) and Leon N. Gillette (1878-1945). The firm operated through 1945, the year of Gillette's death.

Walker graduated from Harvard in 1898 and worked in the New York architectural firm of Warren and Wetmore before forming the architectural partnership with Gillette. Gillette, a graduate of the University of Pennsylvania in 1899, attended the École des Beaux-Arts, in Paris, and worked in the New York architectural firms of Howells and Stokes as well as Babb, Cook and Willard, before joining the architectural partnership with Walker.

Walker and Gillette handled a broad range of residential, civic, and commercial commissions. The firm was well-versed in a variety of architectural styles, including Art Deco, Colonial Revival, Neoclassical, and Georgian Revival, as well as the Tudor Revival, of which the Planting Fields residence designed by Walker and Gillette would become a striking example. Walker and Gillette had also designed the Coes' home in Cody, Wyoming, in 1913. They were frequent collaborators of the interior designer Charles of London, the landscape architecture firm Olmsted Brothers, and artist Everett Shinn, all of whom were key contributors to the enhancement of Planting Fields.

Box 4: Walker and Gillette, Architects, 1920-1927

Arrangement

This box is arranged chronologically by date.

Scope and Contents

After a fire destroyed the original Grosvenor Atterbury-designed residence at Planting Fields in 1918, the Coes soon commissioned the architects Walker and Gillette to design their new Tudor Revival style home, intended to be situated on the same location as the earlier structure. However, the new house was larger and did not use the earlier foundation. Walker and Gillette had previously designed the Coe family's summer residence in Cody, Wyoming, as well as various farm buildings at Planting Fields. This container houses documentation of Walker and Gillette's planning of the design and construction of the Coes' new home at Planting Fields, which was known as Coe Hall.

Box 6: Olmsted Brothers Landscape Architects, 1917-1937

Arrangement

This box is arranged chronologically by date.

Biographical / Historical

In 1918, Andrew Robeson Sargent, responsible for day-to-day landscaping and gardening guidance at Planting Fields, passed away unexpectedly.

The Coe family commissioned the landscape architectural firm of the Olmsted Brothers, with whom the Coe architects Walker and Gillette collaborated on a number of Long Island estates. The Olmsted Brothers practice was led by Frederick Law Olmsted, Jr. (1870-1957), and John Charles Olmsted (1852-1920), son and stepson, respectively, of the legendary landscape architect Frederick Law Olmsted (1822-1903). The Brookline, Massachusetts-based landscape firm was the largest practice in the country, with many notable commissions of public parks, universities, state capitols, and residential communities, as well as private estates and gardens. The Olmsted Brothers associate James Frederick Dawson (1874-1941) oversaw the Planting Fields commission. Dawson continued the work of his predecessors while making many transformative contributions to the landscape features of the estate, enhancing the camellia greenhouse and creating a heather garden, azalea walk, and a stone-edged circular pool known as the Surprise Pool. Dawson designed the vistas surrounding the Carshalton Gates at Planting Fields, and he recommended the photographer Mattie Edwards Hewitt (1869-1956) to capture the seasonal variations of the estate's gardens. Dawson created the landscapes of W.R. and Caroline Coe's South Carolina residence, and he remained a correspondent of theirs until he passed away in 1941.

Scope and Contents

This box contains correspondence tracing a period of approximately twenty years of collaboration between the Coe family and the Olmsted Brothers landscape architectural firm. Detailing the development of the landscape features of Planting Fields, materials preserved encompass reports and letters covering subjects such as the Camellia House at Planting Fields, the installation of the

Carshalton Gates, and the recommendation of the photography of Mattie Edwards Hewitt to the Coe family. In addition, documents pertain to the plants and trees of Planting Fields, including cedars, azaleas, camellias, rhododendrons, wisteria, and others, as well as garden ornaments and the surfacing of drives and tennis courts. A primary correspondent is the Olmsted associate James Frederick Dawson, who led the Planting Fields commission. Also of note are instances of correspondence from Frederick Law Olmsted, Jr.

Series 2: Interior Design

Biographical / Historical

The Coes worked with major art and antique dealers of the day in the United States and Europe, particularly with the firms of Charles of London and Seligmann et Cie, who helped them to shape their collections, influencing and advising them in the creation of the interiors for their newly built Tudor Revival style estate. These collecting endeavors occurred primarily during the 1920s; however, after Mai Coe's untimely death in 1924 the collection continued to be augmented and restored. This series reflects upon the nuance that, in assembling the furniture and decorations of their Tudor Revival style home's interiors, the Coes acquired many English pieces, yet in culminating effect, they did not create a stylistic copy after the English taste. The Coes worked most extensively with Charles of London on the English furnishings and interiors. In addition, this series documents Mai Coe's collecting interest in Continental furniture and decorations, as well as W.R. Coe's purchases in this area on Mai's behalf. The Coes worked closely with the French firm Seligmann et Cie and the decorator Alavoine on conceiving the decorative elements and design of the French Room (sometimes referred to as the Morning Room or the Octagonal Room), as well as commissioning items from the French decorating firm Carlhian for the furnishings of Mai's bedroom suite.

Scope and Contents

This series documents W.R. and Mai Coe's collecting and decorating interests, negotiations, and acquisitions intended for their residence at Planting Fields. Materials preserved in this series include letters, payment files, purchase price information, and correspondence covering art insurance, shipments, and returns, together with descriptions of furniture and decorative objects, and a variety of related correspondence concerning the extensive planning for the interior decorations of the residence at Planting Fields. Major correspondents include the firms of Charles of London and Seligmann et Cie. The series offers a window into the history of collecting in the early twentieth century.

Box 1: Charles of London, 1919-1932

Scope and Contents

Charles Duveen (1871-1940), of the influential Duveen family of art and antique dealers, was known in the trade as Charles of London. Charles had been with the family firm, Duveen Brothers, for forty years before going into business for himself, when he decided not to use his last name professionally at the request of his brother Joseph Duveen, to avoid confusion between the firms. Charles became a specialist of English furniture, particularly of the Tudor and Jacobean periods, and maintained a presence in New York and London. This container houses letters and receipt files for purchases of furniture and decorations. Of particular interest is Charles's correspondence involving the French decorating firm Carlhian (1867-1975), documentation which concerns the production of furniture in the eighteenth-century French style for Mai Coe's bedroom. Originally operating as a dealer making purchases for clients, Carlhian came to specialize in reproductions of period French furniture. Charles's family's firm, Duveen, were important clients of Carlhian. Also of research interest in this container is correspondence with J. Starkie Gardner (1844-1930), who had been Metalworker to King Edward VII, concerning the Coes' acquisition of the Carshalton Gates from the site of Carshalton Park, near Wimbledon, in England.

Box 2: Jacques Seligmann, 1921-1929

Scope and Contents

Jacques Seligmann et Cie was a prominent art and antiques gallery first established in Paris in 1880 by Jacques Seligmann (1858–1923). A larger gallery in Paris was opened in 1900, and a New York office was opened in 1904. Jacques's son Germain Seligmann (1893-1978), who later changed the spelling of his name to Seligman, was active in the firm beginning in 1920, and he took over the firm following his father's death in 1923. Jacques Seligmann's original attention was on furniture and decorative arts,

particularly eighteenth-century French furniture, but in the early twentieth century the firm expanded its focus to include paintings. Jacques Seligmann played an important role in nurturing Mai Coe's interest and enthusiasm for French interiors. This container preserves the letters discussing the creation of a French Room at Planting Fields, and of particular interest in this collection is the correspondence involving Seligmann and the French decorator Alavoine concerning the design, furnishing, and decoration of the French Room. The firm of Alavoine et Cie was founded by Lucien Alavoine, a French decorator specializing in eighteenth-century French interiors. Alavoine had a presence in New York and Paris. Of special interest in this collection are the many letters from Jacques Seligmann to the Coes, which are rich in detail.
